SUBMISSION GUIDELINES / DEADLINE

The completed and filled in entry form, as well as the viewing copy, must be turned in to us by March 15, 2013. Anyone can participate, but up until the age of 13: Individuals, KiTa-Groups, Grade Schools, etc. For every film submitted one must fill out an entry form.

VIEWING AND PROJECTION COPY

One should preferably submit a VHS copy of the film. However, we also accept DVD, Mini-DV and DV Cam.

NOTIFICATION

The participant, whose work is taken, will hear of a decision at the end of April 2013. All other participants whose work is not taken, will receive an email by the end of May (and not by mail due to reasons of costs).
